<b>G1: Grammatical terms / word classes</b>		
<b>G1.1: Nouns<sup>TS</sup></b>	<p>Nouns are usually called ‘naming words’.</p> <p>A common noun is the word used for a class of person, place or thing.</p> <p>A proper noun names a specific person, place or thing. It takes a capital letter.</p> <p>A collective noun is used to label a group of things. (<i>eg. flock, swarm, team</i>)</p> <p>An abstract noun is used for things you cannot touch or see. (<i>eg. beauty, misery</i>)</p>	<p>The <b>girl</b> sat on the <b>chair</b>.</p> <p><b>John Smith</b> drove to <b>Bristol</b> last <b>Tuesday</b>.</p> <p>The <b>choir</b> sang beautifully.</p> <p>He was overcome by <b>sadness</b>.</p>
<b>G1.2: Verbs<sup>TS</sup></b>	<p>A verb is usually seen as a ‘doing’ or ‘being’ word.</p> <p>Some verbs can be classified as modal. (See G4.1c below)</p> <p>Verbs are associated with ‘tense’, usually past or present. (See G4 below)</p>	<p>I <b>walk</b> to school every day.                      Sally <b>was</b> very sad.</p>
<b>G1.3: Adjectives<sup>TS</sup></b>	<p>An adjective is usually thought of as a word that ‘describes’ somebody or something. (<i>eg. old, careful, huge</i>) They usually come before a noun, or after linking verbs such as <i>be, get, seem, look</i>.</p> <p>When we compare two things, we use the comparative form. This is formed by adding <b>+er</b> for most one-syllable adjectives and some two-syllable ones (<i>eg. older, easier</i>), and <b>more</b> for most two+ syllable words (<i>eg. more dangerous</i>).</p> <p>When we compare more than two things, we use the superlative form. This is formed by adding <b>+est</b> (<i>eg. smallest, silliest</i>) or the use of <b>most</b> (<i>eg. most intelligent</i>).</p>	<p>The <b>old</b> cottage had a <b>red</b> door. Those shoes look <b>nice</b>.</p> <p>Andy is quite the <b>taller</b> of the twins. She was <b>more successful</b> than her sister.</p> <p>London is the <b>most important</b> city in England.</p>
<b>G1.4: Conjunctions<sup>T</sup></b>	<p>A conjunction links two words or phrases/clauses together (<i>e.g. when, before, after, while, so, because</i>). Co-ordinating and subordinating conjunctions are dealt with below. (See G3.3 and G3.4)</p>	<p>We’re not going out <b>if</b> the weather is bad. They ate their fish <b>and</b> chips.</p>
<b>G1.5: Pronouns<sup>T</sup></b>	<p>Pronouns are used like nouns as they take the place of nouns in order to aid cohesion<sup>T</sup> and avoid repetition. Common examples of personal pronouns are <i>he, him, she, her, it, they, them etc.</i></p>	<p><b>She</b> waved to <b>him</b>.</p> <p>Jack couldn’t wait for Saturday to come. <b>He</b> loved watching United play. [avoids repeating Jack]</p>

<b>G1.5a: Possessive pronouns<sup>T</sup></b>	<p>The possessive pronouns are <i>mine, yours, his, hers, ours, theirs, its</i>.</p> <p>Notice that they do not have an apostrophe.</p>	<p>The crow flapped <b>its</b> wings and flew off.</p> <p>Is this book <b>yours</b> or <b>mine</b>?</p>
<b>G1.5b: Relative pronouns<sup>T</sup></b>	<p>Relative pronouns introduce relative clauses. (See G3.1a below)</p> <p>They are <i>who/whom, whose, which, that</i>.</p>	<p>That's the boy <b>who</b> lives next door to me.</p> <p>The thing <b>that</b> annoyed me was his silly grin.</p>
<b>G1.6: Adverbs<sup>TS</sup></b>	<p>Adverbs are best seen as words which 'add to the verb'. They can describe how, where or when an action occurred.</p> <p>Pupils should understand the use of <i>-ly</i> in Standard English to turn adjectives into adverbs<sup>S</sup>. (eg. <i>bad – badly, soft – softly etc.</i>) These are usually 'how' words or adverbs of manner.</p> <p>Pupils need to be aware that some adjective to adverb transformations do not follow the <i>-ly</i> rule. (eg. <i>good – well, fast – fast, hard – hard etc.</i>)</p> <p>Adverbs expressing time, place and cause are sometimes overlooked (e.g. <i>then, next, later, soon, never, always, often, everywhere, away, therefore</i>)</p> <p>Adverbs can indicate degrees of possibility. (e.g. <i>perhaps, surely</i>)</p> <p>Adverbs can be used to give extra meaning to an adjective.</p>	<p>She whispered <b>quietly</b> so that nobody could overhear.</p> <p>Jack performed <b>well</b> in the test. He worked <b>hard</b> for his success. [not hardly]</p> <p>We searched <b>everywhere</b> for the missing book.</p> <p>That flimsy building will <b>surely</b> topple over in the wind.</p> <p>My best friend is <b>really</b> kind.</p>
<b>G1.6a: Adverbials<sup>T</sup></b>	<p>An adverbial is a word or a phrase that is used, like an adverb, to modify a verb or a clause.</p>	<p>The bus leaves <b>in five minutes</b>.</p> <p>She promised to see him <b>last night</b>.</p> <p>She worked <b>until she had finished</b>.</p>
<b>G1.7: Prepositions<sup>T</sup></b>	<p>Prepositions are words to express time, place and cause using prepositions (e.g. <i>before, after, during, in, because of</i>)</p> <p>Prepositions are usually followed by a noun phrase.</p> <p>Sometimes prepositions can occur at the end of the clause. (See example)</p> <p>In formal English, the preposition can go before whom or which. (See example)</p>	<p>I left my bag <b>outside</b> the classroom.</p> <p>She'll be back <b>from</b> Australia <b>in</b> two weeks.</p> <p>He jumped <b>over</b> the fence.</p> <p>Who did you go out <b>with</b>?</p> <p><b>To</b> whom should I address this letter?</p>

<b>G1.8: Determiners<sup>T</sup></b>	<p>A determiner is placed before a noun (or noun phrase) to identify or ‘determine’ the noun in some way.                      Commonly they are the articles <i>a, an</i> and <i>the</i>.                      They can also be words like <i>this/that, these/those</i>.                      They can be possessives such as <i>my/your/his/her/its/our/their</i>.                      They can be words which quantify such as <i>some, any, many, several, every etc.</i>                      They can be specific numbers eg. <i>three, twenty, sixty-two etc.</i>                      Pupils should understand the use of the forms <i>a</i> or <i>an</i> according to whether the next word begins with a consonant or a vowel.</p>	<p>He placed <b>an</b> egg in <b>the</b> bowl.                      I like <b>this</b> hat.                      They removed <b>their</b> boots.                      There are <b>several</b> magazines to choose from.  <b>Six</b> guards were waiting outside.                      We say <b>a</b> parasol but <b>an</b> umbrella.</p>
<b>G1.9: Subject and object<sup>T</sup></b>	<p>In a sentence the subject is the person or thing about which something is said – in other words the ‘do-er’.                      The object (if the sentence has one) is the person or thing affected by the action.                      Some verbs can have two objects – technically known as the direct and indirect objects. This is not required pupil subject knowledge, but included to illustrate the added complexities of text analysis!                      Some sentences may not have an object.</p>	<p><b>John</b> kicked the ball. [John is the subject.]                      John kicked <b>the ball</b>. [The ball is the object.]                      She gave <b>her friend some money</b>. [some money – direct object; her friend – indirect object]  <b>Sarah</b> always lies. [Sarah – subject; no object]</p>
<b>G2: Functions of sentences</b>		
<b>G2.1: Statements<sup>TS</sup></b>	<p>A statement is best seen as a sentence that is not a question, exclamation or command.</p>	<p>There are seven days in a week.</p>
<b>G2.2: Questions<sup>TS</sup></b>	<p>Questions are self-explanatory. Although usually cued in by such tags as what, how, when etc., questions can be formed by inversion.                      Questions always end in a question mark.</p>	<p><b>What</b> did you do?                      You did <b>what</b>?</p>
<b>G2.3: Commands<sup>TS</sup></b>	<p>Also known as the imperative form, these are sentences used to give instructions or guidance.</p>	<p>Sit down, please.                      Take the second turning on the left.</p>
<b>G2.4: Exclamations<sup>TS</sup></b>	<p>Within the scope of the KS1&amp;2 tests, exclamations are limited to those starting with <i>what</i> or <i>how</i>.                      Notice that exclamations, although sentences, do not necessarily have a verb.</p>	<p>What a good friend you are!                      How wonderful!</p>

<b>G3: Combining words, phrases and clauses</b>		
<b>G3.1: Sentences<sup>TS</sup> and clauses<sup>T</sup></b>	<p>A sentence is a set of words that is grammatically complete in itself. It makes sense on its own. For example, <i>It's cold.</i> is a sentence, whereas <i>because it's snowing</i> is not.</p> <p>A sentence can be a statement, question, exclamation or command.</p> <p>A clause is a group of words that expresses an event or situation, and usually consists of a subject and a verb. <i>eg. dogs bark; if you want; when it's time.</i></p> <p>A main clause is complete on its own and therefore (as mentioned above) can form a complete sentence. <i>eg. It was raining.</i> (one clause; simple sentence)</p> <p>A subordinate clause cannot exist on its own, but needs to be part of a longer sentence. <i>eg. when we went out.</i> (cannot stand on its own, only makes sense as part of a longer sentence)</p>	<p>Today is Wednesday. It's cold.</p> <p>What fun!</p> <p>It was raining <u>when we went out.</u> [subordinate clause underlined]</p>
<b>G3.1a: Relative clauses<sup>T</sup></b>	<p>A relative clause is a special type of subordinate clause that refers to or modifies a noun. Relative clauses usually begin with a relative pronoun <i>eg. who, which, where, when, whose, that,</i> or an omitted relative pronoun.</p>	<p>That's the girl <u>who lives in Drury Lane.</u> The prize <u>that I won</u> was a book. The prize <u>I won</u> was a book. [Notice the relative pronoun <i>that</i> has been omitted.]</p>
<b>G3.2: Noun phrases<sup>TS</sup></b>	<p>A noun phrase is a group of words that takes the place of and acts like a noun. So instead of writing about <i>foxes</i> we could expand that to <i>all adult foxes</i> or even <i>all adult foxes in the Taunton area.</i></p>	<p><u>My little sister</u> is very cute. Barcelona are <u>the best team in the whole world.</u></p>
<b>G3.3 Co-ordinating conjunctions<sup>S</sup></b>	<p>Co-ordinating conjunctions are words such as <i>and, but</i> and <i>or.</i> They are used to link words, phrases or clauses <b>of equal importance.</b></p>	<p>Jack <u>and</u> Jill went up the hill. We searched behind the shed <u>and</u> under the woodpile. Sue caught a bus <u>but</u> Anna cycled.</p>
<b>G3.4 Subordinating conjunctions<sup>S</sup> and subordinate clauses<sup>T</sup></b>	<p>A clause which has less importance than, less weighting than, or is dependent on the main clause in a sentence is referred to as a subordinate clause. It is a clause that cannot stand on its own as a complete sentence, whereas the main clause in a sentence can. <i>eg. The bull <u>that charged us</u> is back in the field.</i> The subordinate clause 'that charged us' cannot stand on its own, whereas the main clause 'The bull ... is back in the field' can.</p> <p>Subordinating conjunctions introduce the subordinate clause. They are commonly words such as <i>because, although, since, after, since, while etc.</i></p>	<p>We arrived late <u>because the bus had broken down.</u> <u>Although it was late,</u> we weren't tired. I fished <u>until the sun went down.</u> You will be late for school <u>unless you eat your breakfast quickly.</u></p>

<b>G4: Verb forms, tense and consistency</b>		
<b>G4.1a Simple past<sup>T</sup> and simple present<sup>TS</sup></b>	<p>Tense is the verb form that deals with time ie. When something happens or is happening or has happened.</p> <p>The <b>simple present</b> form is: <i>I play, you laugh, she watches, we run etc.</i></p> <p>The <b>simple past</b> form is: <i>I played, you laughed, she watched, we ran etc.</i></p> <p>The simple past form is often made by adding –ed to the base verb (eg. <i>shout – shouted</i>) but there are irregular forms (eg. <i>shine – shone</i>) and in some cases no change (eg. <i>hit – hit</i>).</p>	<p>Every day I <b>walk</b> to school with my friend.</p> <p>Yesterday I <b>visited</b> my gran.</p> <p>Last year we <b>went</b> to France for our holidays.</p>
<b>G4.1b: Verbs in the Perfect form</b>	<p>Another way of talking about the past is through the use of the perfect form of verbs.</p> <p>The <b>present perfect</b> form is made by taking the <b>present tense of the verb ‘to have’</b> (eg. <i>I have/she has</i>) + the <b>past participle of the actual verb</b> (eg. <i>played/looked</i>)</p> <p>The <b>past perfect</b> form is made by taking the <b>past tense of the verb ‘to have’</b> (eg. <i>I had/she had</i>) + the <b>past participle of the actual verb</b> (eg. <i>entered/caught</i>).</p> <p>The past perfect refers to a time <b>earlier than before now</b>. It is used to make it clear that <b>one event happened before another</b> in the past. Consider:</p> <p><i>I <b>had saved</b> my work before the computer crashed.</i></p> <p>The use of the past perfect tells us that I had saved my work before the event.</p>	<p>I <b>have lived</b> in Bridgwater since 2010.</p> <p>She <b>has visited</b> London several times.</p> <p>Mum <b>had left</b> by the time I got home.</p> <p>He was tired because he <b>had not slept</b> very well.</p>
<b>G4.1c: Modal verbs<sup>T</sup></b>	<p>Modal verbs are verbs which are used to express such ideas as possibility, ability or obligation.</p> <p>The modal verbs are: <i>can/could will/would shall/should may/might must/ought</i></p> <p>They are a type of auxiliary verb and are followed by the infinitive of the verb. (Nb. Ought is followed by to + infinitive)</p> <p><i>eg. can help... might go... will be... ought to eat...</i></p>	<p>I <b>can</b> help you if you wish.</p> <p>You <b>should</b> look after your little brother.</p> <p>It <b>might</b> rain tomorrow.</p> <p>I <b>must</b> look out for that book.</p>

<p><b>G4.3: Subjunctive verb Forms(contd)</b></p>	<p>Certain verbs attract the use of the subjunctive, especially in formal language. These are:</p> <p><i>to advise (that)    to ask (that)    to command (that)    to demand (that)</i>  <i>to desire (that)    to insist (that)    to propose (that)    to recommend (that)</i>  <i>to request (that)    to suggest (that)    to urge (that)</i></p>	<p>The headteacher insists that all pupils <b>be</b> honest.</p> <p>The shop-keeper demanded that she <b>pay</b> on time.</p> <p>I suggest that the game <b>begin</b> at once.</p>
<p><b>G4.4: Passive<sup>T</sup> and active<sup>T</sup></b></p>	<p>Many verbs can be put in the active or passive voice.</p> <p>In the <b>active voice</b>, the subject performs the action.  <i>eg. The dog bit Ben.</i>                      The subject (the dog) performs the action of biting Ben.</p> <p>Rewritten in the <b>passive voice</b>, this sentence becomes:  <i>Ben was bitten by the dog.</i>                      Here the subject (Ben) is on the receiving end. The two sentences give similar information, but there is a shift in focus. The first is about what the dog did; the second is about what happened to Ben.</p> <p>Passive forms are common in impersonal, formal styles. They remove identification of the 'agent' and allow generalization.</p>	<p>Somebody saw you. (Active)                      You were seen by somebody. (Passive)</p> <p>Alex rang the bell. (Active)                      The bell was rung by Alex. (Passive)</p> <p>Mr Jones arranged the trip. (Active)                      The trip was arranged by Mr Jones. (Passive)</p> <p>Application forms may be obtained from the office.                      It was recommended that a letter of complaint be sent.</p>
<b>G5: Punctuation</b>		
<p><b>G5.1: Capital letters<sup>TS</sup></b></p>	<p>Capital letters are used to demarcate sentences.</p> <p>Capital letters for names of people, places, the days of the week, months of the year etc. (Proper nouns)</p> <p>The personal pronoun I is always a capital.</p>	<p><u>T</u>his is the first sentence. <u>T</u>his sentence comes next.</p> <p><u>H</u>er address is 15 <u>O</u>rchard <u>R</u>oad, <u>Y</u>eovil, <u>S</u>omerset.</p> <p><u>W</u>hen we were in <u>L</u>ondon we saw <u>T</u>ower <u>B</u>ridge.</p> <p><u>S</u>am and <u>I</u> are best friends.</p>

G5.2: Full stops <sup>TS</sup>	Full stops are used to demarcate sentences.	
G5.3: Question marks <sup>TS</sup>	Question marks are used to demarcate sentences when the sentence is a question. The question mark takes the place of a full-stop in such cases.	
G5.4: Exclamation marks <sup>TS</sup>	Exclamation marks are to demarcate sentences when the sentence is an exclamation. The exclamation mark takes the place of a full-stop.	
G5.5: Commas in lists <sup>TS</sup>	Commas are used to separate items in a list. The accepted practice is to use 'and' to separate the final two list items.	In the box were apples, pears, bananas, oranges, lemons and grapes.
G5.6a: Commas <sup>T</sup> to clarify meaning	<p>Commas to clarify meaning or avoid ambiguity<sup>T</sup> in writing. It sometimes corresponds to a pause in speech. <i>eg. Soon after the dinner was interrupted by a loud bang.</i></p> <p>This becomes clearer with the insertion of a comma. Thus: <i>Soon after, the dinner was interrupted by a loud bang.</i></p>	<p>Let's eat Grandma. <i>or...</i> Let's eat, Grandma.</p> <p>Jaimie Oliver talks about cooking his family and his dog. Jaimie Oliver talks about cooking, his family and his dog.</p> <p>Stop clubbing baby seals. <i>or...</i> Stop clubbing, baby seals.</p>
G5.6b: Commas <sup>T</sup> after fronted adverbials	<p>A fronted adverbial is simply an adverbial (see G1.6a above) placed at the beginning of a sentence.</p> <p>When a sentence begins with a fronted adverbial, a comma is used to separate it from the rest of the sentence.</p>	<p><b><u>Before we begin</u></b>, make sure you've got a sharp pencil ready.</p> <p><b><u>Without stopping to think</u></b>, Tom rushed through the door.</p>
G5.7: Inverted commas <sup>T</sup>	<p>Inverted commas<sup>T</sup> (or 'speech marks')<sup>T</sup> are used to demarcate direct speech<sup>T</sup>.</p> <p>Other punctuation to indicate direct speech (<i>e.g. a comma after the reporting clause and end punctuation within inverted commas</i>) is needed to ensure clarity. (See examples opposite for correct use of inverted commas, end punctuation and capital letters.)</p> <p>Inverted commas must not be used when writing indirect or reported speech. <i>eg. Amy said "that she was going home."</i> This is <u>incorrect</u> as no direct speech is used.</p>	<p>"Stop talking and do your work," said the teacher.</p> <p>The teacher said, "Stop talking and do your work."</p> <p>"Stop talking," said the teacher, "and do your work."</p> <p>"Can I go now?" she asked.</p> <p>"Watch out!" she shouted. "Are you trying to kill us?"</p>

<p><b>G5.8: Apostrophes<sup>TS</sup></b></p>	<p>Apostrophes are used to show the omission of one or more letters in contracted forms. <i>eg. I'm, can't.</i> The new framework uses both the term <b>omission</b> and <b>contraction</b>.</p> <p>Apostrophes are used to mark possession in nouns<sup>S</sup>. <i>eg. Sam's book – the book belonging to Sam</i> <i>the cat's whiskers – the whiskers of the cat</i></p> <p>Apostrophes are placed after the '-s' in plural nouns which end in '-s'. <i>eg. the dogs' collars – the collars of the dogs</i> <i>the boys' coats – the coats belonging to all the boys</i> If the plural form is irregular (<i>eg. children, men etc.</i>) the possessive is formed as above for the singular. <i>eg. the women's shoes – the shoes of the women</i> <i>The mice's tails – the tails of the mice</i></p> <p>If the singular noun ends in '-s', there are two schools of thought regarding the position of the apostrophe. <i>eg. the poems of John Keats may be written as either Keats' poems or Keats's poems.</i></p>	<p>Anna says that <b>she's</b> going swimming.</p> <p><b>He'll</b> be hoping to win the last race.</p> <p>The jockey fastened the <b>horse's</b> saddle.</p> <p>Andy borrowed <b>George's</b> football boots.</p> <p>The referee checked all the <b>players'</b> boots.</p> <p>The <b>babies'</b> cots were placed in a long line.</p> <p>The teacher asked to see the <b>children's</b> books. The <b>policemen's</b> helmets were all hanging up.</p> <p>The Bible has many accounts of <b>Jesus'</b> miracles. [or <b>Jesus's</b> miracles]</p>
<p><b>G5.9: Punctuation for parenthesis</b></p>	<p>Parenthesis is where a word or phrase is inserted into a sentence to explain, elaborate, or add a bit more information as an 'aside'. Brackets<sup>T</sup>, dashes<sup>T</sup> and commas<sup>T</sup> can all be used to indicate parenthesis<sup>T</sup>.</p> <p>Brackets are the most formal (and most obvious) way of showing parenthesis. <i>eg. Sam and Maggie (his two oldest children) are coming to visit him.</i></p> <p>Commas are a less forceful way of showing parenthesis but should be avoided if the sentence or aside already contains commas. <i>eg. Becky is, I believe, the fastest runner in the class.</i></p> <p>Dashes are the least formal, often used for notes, memos, e-mails etc. <i>eg. His trainers – talk about smelly – really were very unpleasant!</i></p> <p>The sentence into which the parenthesis is introduced should be grammatically correct in its own right. In other words, if you were to remove the part in parenthesis, the sentence that remains should be grammatically correct.</p>	<p>Many people believe that UFOs (<b>Unidentified Flying Objects</b>) regularly visit Earth.</p> <p>Our new headteacher, <b>Mrs Robertson</b>, will be taking assembly today.</p> <p>Joe's fun to be with - <b>he's always cracking jokes</b> - but I could see that he wasn't himself.</p>

G5.10: Colons <sup>T</sup>	<p>The main use of a colon is to introduce lists. <i>eg. G5.13: Hyphens	<p>Hyphens are used to join the two parts of <b>some</b> compound words. (Nb.
